

March of Dimes Ends; Over \$13,000 Given

An LST took honors in the Amphibious Force March of Dimes drive which ended last month. USS LST 1122, whose crewmen gave the drive its first contribution, had the highest average donation per capita ever recorded by a Force

ship in a charity drive.

When the LST returned from overseas, a check for \$2,002.50 was presented to a young polio victim for the National Foundation for Infantile Paralysis. This money was received in voluntary donations from men of the ship while - 1956it served in the Far East. Lt. J. R. Wilson is CO of the 1122.

USS Calvert (APA-32) closed the drive with equal enthusiasm when men of that ship gave the dimes drive a check for \$2,032. P.I. Landing To Test Marine, Navy Power

MANILA, P.I. (AP)—Combined air, sea and land units of the U.S. 3rd Mar. Div. and the Pacific Fleet will stage a large-scale landing exercise off the Philippines' east coast of Luzon Island in early April, the Foreign Office announced Saturday.

The operation, involving some 20,000 men, will be held to test the striking power and mobility of the Pacific Fleet in the event of an attack on the Philippines. The U.S. is bound to come to the aid of the Philippines under their mutual defense assistance pact.

A U.S. Navy spokesman said the operation is an "exclusively unilateral action by American forces under the United States-Philippine mutual assistance de-fense pact."

He said the exercise will be conducted in an almost inaccessible 16 AUGUST, 1954

A UNITED STATES NAVY "MERCY" FLEET BEGAN CONVERGING ON INDO. CHINA SUNDAY TO TAKE PART IN THE MASS EVACUATION OF HUNDREDS OF THOUSANDS OF VIETNAMESE REFUGEES FLEEING COMMUNIST-RULED NORTHERN

REAR ADMIRAL L.S. SABIN, COMMANDER AMPHIBIOUS GROUP WESTERN PACIFIC, TOLD A PRESS CONFERENCE SHORTLY BEFORE HIS DEPARTURE THAT THE U.S. GOVERNMENT HAD AGREED TO A REQUEST BY THE FRENCH AND VIET NEMESE GOVERNMENTS TO ASSIST IN THE OPERATION -- "ONE OF THE LARGEST MASS CIVILIAN SEA EVACUATIONS IN HISTORY."

SABIN ESTIMATED THE NUMBER OF EVACUEES, AT "UPWARDS OF 100,000

TO A QUARTER MILLION OR MORE."


HE SAID TRANSPORTS, CARGO SHIPS AND AMPHIBIOUS CRAFT WILL BE SENT TO THE HAIPHONG AREA TO PICK UP THE REFUGEES AND EVACUATE THE SOUTH TO SAIGON. HE DECLINED TO SPECIFY THE NUMBER OF VESSELS PUT INTO THE OPERATION

"WE'LL DO THE JOB AS FAST AS WE CAN AND AS EFFECTIVELY," SABIN TOLD NEWSMEN. "THIS WILL NOT BE A PLUSH JOB. WE'LL HAVE MANY. MANY PEOPLE AND WE'LL HAVE TO GET OUT AS MANY AS FAST AS WE CAN. WE'LL LOAD THEM WITH DUE REGARD FOR SANITATION AND AS ORDERLY AND COMFORTABLE AS POSSIBLE UNDER THE CIRCUMSTANCES."


ASKED WHETHER U.S. NAVY AIRCRAFT WILL COVER THE OPERATIONS. SABIN REPLIED: "I HOPE WE CAN TAKE CARE OF OURSELVES IF ANYTHING

HAPPENS. I DON'T ANTICIPATE IT."
SABIN SAID, "REGARDLESS OF WHAT ELSE WE MAY THINK OF THE COM-MUNISTS. I AM SURE THEY MUST REALIZE THIS IS A HUMANITARIAN EFFORT
