

John, what a really wonderful experience to read your No. 57 Newsletter. If you have been doing this 57 times – Boy, my hat is off to you. It's really a great job. Off and on over the years, I have scanned "Reunion Notices," but was never able to pick up any on the USS CALVERT. Thanks for placing this year's reunion in the "The American Legion," magazine.

I am glad to see the 2008 Reunion is in Oklahoma City so I'll be able to attend. It's only up (north) on E-35 from Flower Mound, TX. We are about 25 miles north of Dallas, TX. So if my health holds out, I am planning to be there. Maybe I will be able to recognize some of the old shipmates.

In this regard, I went through some of my files and found three (3) pictures. Two are of the USS CALVERT returning to San Diego in Sep 1951 and the third is a picture of the 3<sup>rd</sup> Deck Division (that's the one that looked after the aft cargo hold and that portion of the ship). I am sitting next to the Division Chief, on his right – note white hat on the back of my head. The BM3/c on my right is Adam Chereami from Yonkers, NY. The 3<sup>rd</sup> Division Petty Officer was Robert Lois Swords, BM2/c. He is the second man on the left from our Division Officer – who I think was Mr. Small or Mr. Little. Some faces in the photo look familiar, but no names come up.

As we discussed in our telecom, I was one of the Reservists that were recalled to active duty. I first served a Minority Cruise in the Regular Navy from December 1942 to June 1946. Why, I don't know, but upon discharge, I signed into the Inactive Reserve Program. In December 1950 (between Christmas and New Years), I I received orders to report to Treasure Island NS for ship assignment. That ship was the USS CALVERT. At this time I was married with three children (3-1/2, 2 & 3 mos). I was on leave of absence from my California State Park Ranger assignment to attend University of California, Berkeley. When the ship returned to San Diego in September 1951, I started action on a hardship discharge. It was granted in October 1951.

I spent 19 years with the California State Park system as Park Ranger, Park Superintendent, park planner and administrator. In 1967, I accepted a environmental planning position with the U. S. Army, Corps of Engineers and retire from it in May 1985. I had assignments in the Office, Chief of Engineers, Washington, DC and Portland, OR. In 1972, I accepted a position as Natural Resources Planner for the Secretary of Defense and spent that year in the Pentagon. Boy, what an experience that was. I am widowed – my wife, Louise passed away on 8 Nov 2005, after losing her battle with Parkinson's Disease. We had 59-1/2 years of a wonderful marriage. My immediate family consists of 3 sons, 2 former daughter-in-laws, 1 daughter-in-law, 5 grand daughters, 1 grand son, 5 grand sons-in-law, 1 grand daughter-in-law, 2 greatgrand daughters, 3 great-grand sons, and 2 Great-grand nephews. I am living with my oldest son and family. He and his family all live here in the North Texas area. The rest of my family live in southwest Washington and the Portland, Oregon areas.

After the blast a fence was installed around the whole area to keep people from the site. Almost immediately people began to leave tokens of love and hope on the fence. Today only 200 feet of the original fence remains. After we had returned home, Dale, hung a Calvert license plate from the fence. Each month all items are collected and preserved in the museum Archives. Items now total over 60,000.

Quite a change since we were last there, one year after the blast. If you ever get to Oklahoma City be sure to stop and go through the Museum. It is really worth the trip.
