To my late husbands shipmates,

I am writing to you with the hope that one of you will remember serving on the U.S.S. CALVERT. APA32 with John M. Bowker. Specifically during the time it was docked in Da Nang. Christmas, 1965 off-loading war supplies. The U.S.S.CALVERT. APA 32 remained until Jan. 18, 1966 as station ship and served as a vital communications link between the Seventh Fleet and Da Nang. My husband was a Guners Mate, and told me stories about taking sollders up and down the rivers. I need to prove the Calvert was docked in Vietnam and that he served in Brown Water.

My sincere hope is that someone will contact me with information that would assist me with an Entitlement Claim. John died on Oct. 16, 2008 of Stage 4 Lung Cancer. If any of you have a disability claim that has been granted for service in Vietnam, aboard the U.S.S. CALVERT APA32 during the time my husband served, please contact me. Or if you have proof the U.S.S. CALVERT docked anywhere in Vietnam from Nov. 16, 1964 through May 16, 1966 please help me.

I want to thank you again for the time and effort you find to keep your CALVERSION going. I always look carefully at each edition to see names of shipmates from my era. I came aboard in Yokosuka in March of 1953 and served as Gunnery Officer and later Personnel Officer and Ship's Secretary for Capt. Hillies. Calvert will always be a fond memory as it was my first sea duty assignment

Korean duty, towards the end of that conflict, and Operation Passage to Freedom in Vietnam were highlights of that tour timeframe which ended for me in mid summer of 1955. As a young Ensign, a first in my life occurred on Calvert that I will always remember, and that was casting my first Presidential Election vote while at sea out in the middle of the Pacific. I have often wondered whether our votes were actually counted, but the symbolism was what mattered!

I just turned 80 yesterday, which is cause for a little nostalgia, and so this part of my life came to mind and I hope some of you guys from the early 50's will read this and recall as well.

I want to thank you so much for sending me the Calversion newsletter which gives me great pleasure to read. I served as a jr. officer aboard the Calvert from 1962 to 1965. I was very interested in the article by Richard Considine in vol. no. 61 - 2010. Those guys taught me so much about how to be an effective O.D. on the bridge as well as how to relate to the men in the Division. It is a pleasure to see the laughter and smiles on their faces that has not changed in forty six years. It seems just like it was playing poker with them on a slow night at sea. I am sending you a table lighter with the engravings of the Calvert and her flags that was so beautifully done. It was given to me as a gift upon leaving the Calvert in 1965. There are probable a number of these around but if it can be used at the museum that would be great.

I also would like to tell you that I was born and raised on a farm in Minnesota and graduated from St Olaf College in 1958. I know Kenyon pretty well because it was close to Northfield and I played football there with a student by the name of Bob Kelass. Maybe some of the family is still around there but it is interesting to know that the publisher of the Calversion lives so close to where I went to school.

4364 Arcadia Dr San Diego, Calif. 92103 I keep meaning to write you and tell you that my mother, Mrs. William M. Kaufman, died a number of years ago and that you can stop sending me the *Calversion*. I'm glad I had not gotten around to it. Tom Glickman's memories of my father were very touching and heartwarming. To think that my father did and said things that people remember fifty years after the fact makes me ever more proud to be his son.

He was exactly as Tom described him, intelligent, witty, and devoted to the men who served under him. I remember the tussle with Senator Smith. Though he wouldn't have said it, he was standing on principle. He thought that his, and others, sailors were being gouged and preyed upon by unscrupulous merchants who would then game the system to get the Navy to dun the men and punish them. He recognized that the men were not blameless but thought they had few options in a "navy town".

I don't think that he felt that the Smith incident was the reason he was passed over, however. He felt he had been labeled an "education" officer, not a seagoing type. Between the *Preble* and the *Pennsylvania*, at the height of WWII, the Navy sent him to Post-Graduate school. He later did a tour as an instructor at the Naval Academy and two tours at the War College, one as a student and one as an instructor. He thought this left him marked as not "warrior" enough.

He gave it a good run, however. He followed the Calvert with a stint as the Commodore of Desron 21 and a couple of years as Chief of Staff for the Seventh Fleet. He was told by people serving on a couple of selection boards that "If they could have made one more Admiral . . ."

In the long run he felt vindicated when the bank he went to work for on his retirement, a predecessor to Wells-Fargo, made him Vice-President.

Finally, as Tom said, he was a great teller of sea stories. He also was a teller of golf stories and, I am quite sure, he is up there chafing at the inability to tell one and all the story of his death. You see he didn't die once, but twice. He was playing the fourteenth hole at Moffat Field with three friends. He had a nice chip shot in from just off the green. It went in the hole. He walked up, bent over to pick up the ball, and fell over dead. One of the men playing with him had been a Fire Chief. He and another man instantly began CPR and the third ran for the ambulance.

They took him to the local hospital and resuscitated him. The Docs never really figured out what went wrong. It wasn't a heart attack. They installed a pacemaker and he went on about his life. About two years later, the same four guys are playing Moffat. Dad had a nice chip shot up to the fourteenth. This time he didn't make the shot and they couldn't restart his heart. I'll bet St. Peter is sick of hearing the story.

Anyway, thanks to you and Tom for bringing his memory back to life even if for only a moment.






